ELECTIVE PUPPY WARRANTY

The elective puppy warranty covers your puppy for fourteen days against parvo virus, distemper, corona virus, canine influenza, hypoglycemia, kennel cough, and any undetected health ailment that would prevent the puppy from leading a normal life. The purchaser is responsible for taking the puppy for a health check by Dr. Moore at the Mt. Airy Pet Hospital (923-1100) within the first fourteen days following purchase or the warranty is void. The cost of this elective puppy warranty is thirty-five dollars. During the initial exam, should Dr. Moore find this puppy to be a poor health risk or detect any serious physical health problem that would require prolonged veterinary care, The Dog House will cover any reasonable medical expenses *excluding office visits* until the puppy is again healthy. Payment of such expenses will occur within fourteen days of receipt of the veterinarian's written vet report, including expenses, and a bon a fide receipt for payment of the expenses. If the puppy should die within the 14 day elective puppy warranty, the client has the choice of a full refund of the price of the puppy or a credit of the full purchase price towards the selection of a replacement puppy.

The customer understands the puppy is being sold without any written or implied warranty. The customer also understands The Dog House has sold the puppy as is and does not warranty the puppy against any of the above mentioned diseases and that any veterinarian costs will be the sole responsibility of the purchaser.

LIMITED ONE YEAR EXTENDED WARRANTY

The Dog House warrants your puppy for 1 year from the date of purchase against hereditary and congenital disorders that may interfere with your puppies ability to lead a normal life. The Dog House provides your pet solely for the purpose of a *companion pet*. There is no warranty expressed or implied regarding the puppy's personality or the ability to show or breed the puppy. In the event a licensed veterinarian certifies your puppy to have a congenital or hereditary defect within 1 year from the date of purchase, the client should provide The Dog House with the veterinarian's written report within 14 days of diagnosis. The client may then choose a replacement puppy or a full credit of the original purchase of the puppy. The client may take up to 6 months to select a replacement puppy.

LIMITED LIFETIME WARRANTY

In the event the puppy should die, whether by or from natural causes, The Dog House will give the original purchaser a credit of 25% of the original purchase price toward the purchase of a replacement puppy of your choice.
